Minutes

The meeting began at 10:00 AM.

Jim LaGraffe welcomed everyone and asked if they could introduce themselves as there were a number of new people joining the meeting for the first time.

Community Veterans Engagement Board (CVEB).

Joining us today is Ken James, Chair of the Loudoun County Community Veterans Engagement Board who generously provided an overview presentation. Please see:

Ken shared information about what a CVEB is comprised of, how they work, what they do and don't do, their mission, plans, and accomplishments, and future goals. There are several positive reasons for having a CVEB for regions. Ken has helped other areas develop CVEBs and has offered to help advise this group on establishing a CVEB for our region, and the group was in favor of moving forward with this approach.

<u>Next Steps</u>. Jim will reach out to Ken to set up some time to talk about setting up an Executive Council. Ken offered to send Jim a copy of their Bylaws, to see its structure and model, as every CVEB is set up differently and they will go from there. If there are individuals who are interested in helping to spearhead this effort, please let Jim know. Jim may reach out to others to take the lead because he doesn't really qualify. He is happy to help and support and try to keep this initiative moving along. It is critically important that the various veteran groups whose mandates are to provide services for our veteran's pick this up and move it along. It is important that a veteran or someone who understands what veterans need is leading this effort because oftentimes civilians don't understand this.

Service Member, Veterans, and Families Mini-Conference. He shared that the event planning group met last week and was able to make progress on a few things.

- Anthony Barnes has submitted the speaking engagement request to the Vietnam War Commemoration Department of DOD.
- He will also proceed with coordinating the Virginia National Guard Brass Quartet to perform songs before and after the ceremony.
- Germanna Daniel Technology Center has been reserved for the location.

There was some discussion about Congresswoman Abigail Spanberger coming the morning of the event to welcome everyone and kick off the event.

<u>Community Engagement and Partnerships Coordinator Updates</u>. Angela Jameson, Community Engagement and Partnerships Coordinator, Suicide Prevention Program, Central Virginia VA Healthcare System mentioned that Jennifer Kelly who is her counterpart covering the Martinsburg region is back. She had been tasked for about four months with a Suicide Prevention Coordinator, but she is back now, and Angela has been keeping her in the loop and can pass along any information or requests for support. They are also in the process of hiring another Community Engagement and Partnerships Coordinator for the Richmond area.

<u>Resource Specialist Position in Warrenton Update</u>. Jennifer Sztalkoper, Virginia Veteran and Family Support (VFS) advised that they will close that position tomorrow as they have received a very good response and are happy with the talent who has responded. They are looking to begin conducting interviews in Front Royal, Virginia on the 30th of November, which would place onboarding sometime after Christmas (as long as the application pool is sufficient and interviews go well), and a start date in 2024.
