the Puller Center (named after General Puller) falls under Sandy's peripheral. It is a DVS center in Vint Hill, a residential rehab center.

Veteran overdose and suicide support. Starting with us on February 5th. Embedded in our Coresponse team. Will go through some training for a month or two.
